


**Ellen Wehrman Community Garden Contract**  
**Burlington Street, Bordentown, NJ 08505**  
**(across from Clara Barton School playground)**

**Mission Statement:** The Ellen Wehrman Community Garden of Bordentown City strives to develop a community of citizens who work together to create a successful community garden and improve their community and beyond. The garden provides the opportunity for participants to grow their own fresh produce, as well as produce that can be donated to local organizations and individuals in need. The garden also provides educational opportunities for all ages to learn about gardening, sustainability and wellness.

**Rules, Terms and Condition for Participation:**

If accepted as a gardener, I will abide by the following rules, terms and conditions.

1. The fee for the use of the garden is **\$25** per plot, per year. Payment must be received by May 1. There are no refunds past July 1.
2. Once assigned a plot, I will cultivate and prepare plot for planting by **May 1** and plant within two weeks or by June 1. If my plot is uncultivated by June 1, I will lose my plot for the gardening year.
3. I will ensure that my plot will be cared for at all times. If I must abandon my plot for any reason, I will notify the Garden Coordinator.
4. I will keep my plot, paths and surrounding areas free of weeds, pests and diseased plants. If my plot become unkempt, I understand I will be given 1 week's notice to clean it up. I further understand that failure to do so may result in my forfeiture of my plot. Forfeited or abandoned gardens will be assigned to the next person on the waiting list. Gardeners who continue to neglect their plots may not be invited back the following year. No garden fees will be refunded.
5. Only 1 plot per household depending on availability.
6. I will not expand my plot beyond the allotted plot size or into paths or other plots. I will keep all my plants within the limits of my garden.
7. a) No pressure-treated wood of any kind is to be used in the Garden.  
b) Only organic gardening methods may be used. I will use only OMRI (Organic Materials Review Institute) approved products for pest and weed control and fertilizers in my plot. A list of these products can be found in the garden shed. When purchasing, acceptable products have this symbol on the label:  

8. Members shall harvest crops in a timely method, and keep their plot free of overripe, rotting and spoiled fruit and vegetables. The Garden Coordinator has right to remove them and give them to a food bank.
9. I agree to contribute volunteer hours toward community gardening efforts. This includes opening and end of season work days, and maintenance of common areas during the gardening season.
10. I will remove all plant material including weeds, and decorative objects or structures and bring it back to its original state at the closing of my plot, November 1.
11. I will only pick crops from my own plot.
12. I will dispose of weeds and diseased plants in bins provided. Other plant material may be placed in the compost pile.
13. Guests and visitors, including children and pets, may enter the garden only if I accompany them. They must follow the rules, terms and conditions stated here. I will supervise children and pets at all times when they are in the garden. I am solely responsible for the behavior of my guests.
14. I will clean and return all community garden tools to the shed after use.
15. I will NOT consume alcoholic beverages, smoke or use illegal drugs on the Garden property.
16. I forfeit my right to sue the owner of the property.
17. I will abide by hours set by the garden committee (dawn till dusk); be courteous of other gardeners and garden neighbors with regards to noise (loud talking, music).
18. Garbage and recycling (no glass allowed in garden) must be disposed of properly.
